By providing certified training through accredited centres, we aim to prevent well control incidents from occuring.

The registration fees for new members are:

Membership is valid from the 1st of January to the 31st of December each year. Members renew annually on the 1st of January.

ACCREDITATION

Becoming an IWCF accredited training centre will allow you to deliver our programmes of training and assessment to your candidates.

There are two types of accreditation:

- Primary
- Associate

All organisations applying for primary centre accreditation must become a member. Once confirmed as a member you can apply for primary centre accreditation. Associate centres are directly linked to the primary centre.

Once accredited as a primary centre you can apply to add associate centres.

ACCREDITATION FEES

Primary centre - £2500

Associate centre - £1500

Additional associate centre - £200

Accredited centres will complete a renewal process each year to maintain accreditation. The primary centre renewal fee is £995 and the associate centre renewal fee is £495. If a primary centre has more than one associate centre, only one associate centre renewal fee will be applied. Centres can also pay a £200 administration fee throughout the year to change the location of their centre if required.

HOW TO APPLY

Become a member by completing our membership application and paying the membership fee.

Once you are an approved member, complete and send your primary centre application to accreditation@iwcf.org.You will be asked to provide information of physical resources, staff resources, management systems and training materials.

We will send you an invoice for 50% of the accreditation fee.

We will review your application and once approved we will issue your accreditation agreement and the invoice for the remaining 50% of your fee.

Once your have returned your accreditation agreement and paid the fee, you will be granted provisional approval.

You will be given FORUM login details and allocated an IWCF Account Coordinator. They will contact you to explain FORUM and to answer any questions you have.

An IWCF Auditor will vist your centre to conduct your audit. Following a successful audit you will be granted full accreditation.

Once fully approved as a primary centre, you can apply for associate accreditation.



INSTRUCTORS

The instructors role is to develop and deliver effective training to candidates. Instructors must use the course materials accredited for the centre they are instructing at.

Instructors are required for our Drilling Well Control and Well Intervention Pressure Control (WIPC) programmes at level 2, 3 and 4.

REQUIREMENTS



To instruct a level 2 programme it is mandatory for applicants to hold a minimum level 3 certification. To instruct a level 3 and/or 4 programme it is mandatory for applicants to hold a minimum level 4 certification. At least 90% in each of the assessments must be achieved.

Applicants must also meet one of the following requirements:



A minimum of 2 years field experience in a supervisory role. For WIPC, experience as a Wireline Wellsite Supervisor, Coiled Tubing Wellsite Supervisor or Snubbing Wellsite Supervisor is required. For Drilling Well Control, experience as a Driller, Toolpusher or Wellsite Engineer is required.



A Bachelor of Science degree in a relevant subject and at least one year field experience in a role which requires a current IWCF level 3 or level 4 certificate.



A relevant vocational qualification and at least one year field experience in a role which requires a current IWCF level 3 or level 4 certificate.

TRAIN THE TRAINER

All instructors must hold a recognised training/teaching qualification. IWCF offer the Train the Trainer course for instructors:

Our Train the Trainer course will enable instructors to teach effectively and confidently in the classroom, helping them to develop effective training materials and techniques that meet the course objectives and needs of learners.

Train the Trainer is endorsed internationally by ILM and fulfils the requirements for IWCF instructors. Costs are $\pm 900 / 1,080 / 1,350$.

ASSESSORS

The practical assessors role is to evaluate candidates performance during their practical assessment. Assessors will grade each candidate using a set criteria issued by IWCF.

Assessors are required for Drilling Well Control level 3 and 4.

REQUIREMENTS



It is mandatory for applicants to hold a current level 4 certification in our Drilling Well Control programme. A minimum of 90% in each of the assessments must be achieved.

Applicants must also meet one of the following requirements:



A minimum of 2 years field experience in a supervisory role. For Drilling Well Control, experience as a Driller, Toolpusher or Wellsite Engineer is required.



A Bachelor of Science degree in a relevant subject and at least one year field experience in a role which requires a current IWCF level 3 or level 4 certificate.



A relevant vocational qualification and at least one year field experience in a role which requires a current IWCF level 3 or level 4 certificate.


ASSESSOR TRAINING

All assessors must attend the IWCF Assessor course as part of their accreditation:

Our Assessor course is designed to ensure assessors are competent and confident in their ability to assess practical assessments, and ensure all candidates receive a consistently high global standard of assessment.

The assessor course is mandatory for all new assessors . Costs are £1,800 / \$2,700
