Coronavirus (COVID-19) – Business Continuity Update

IWCF continues to closely monitor the developing COVID-19 situation. Our priority is to ensure the health, safety and wellbeing of our employees, members and visitors whilst continuing to deliver our services.

We are working hard to ensure that we take all necessary steps to mitigate any possible impact to our customer operations while maintaining the welfare of our employees, customers, contractors and other stakeholders.

We wanted to share some information and new measures we have introduced to ensure we operate "business as usual" over the coming weeks.

## Our Employees

We have adopted a home working policy. We are confident our approach to working remotely means the measures we have in place can ensure business continuity.

We are encouraging staff to limit face-to-face contact unless absolutely necessary to help reduce the risk of infection. Our employees are available to discuss any issues by phone, or have virtual meetings using Microsoft Teams.

All employees are available as usual on their mobile numbers and email addresses.

## <u>Travel</u>

Travel is restricted in line with official advice. Business travel is restricted to 'essential' travel only.

Official guidelines on isolation are being followed for employees returning from any affected areas.

We have temporarily suspended onsite scheduled visits for audits, Train the Trainer and Assessor Courses until further notice.

## **Candidate Certificate Extensions**

Since announcing the certificate extension procedure on Friday 13th March 2020, we have received a high volume of requests which we are currently processing as quickly as possible.
