## <u>Notes</u>

<sup>1</sup> Invigilation fees for classroom-based assessments (online and paper) are variable. The fees will increase for specific countries, and centres will be notified if they are affected by the increase.

<sup>2</sup> Maximum of 3 candidates per schedule.

<sup>3</sup>Chargeable when schedules are cancelled on FORUM, or a change of date is requested, less than 24 hours before the start of an assessment.

<sup>4</sup> Chargeable when schedules are cancelled on FORUM, or a change of date is requested, between 24 and 72 hours before the start of an assessment.

<sup>5</sup> Courier costs, for paper assessments, will be charged for the shipment of assessment papers from IWCF to the invigilator and from the invigilator to IWCF. These costs are variable dependent on the weight/dimension of the package and the location of the centre.

<sup>6</sup> Local printing of assessment papers may be done in some circumstances. The cost will be chargeable to the centre and are variable dependent on the location of the centre and the number of assessments printed.

<sup>7</sup> Fifty percent of the primary centre accreditation fee is payable on application and is non-refundable.

<sup>8</sup> The Administration fee will be charged when a centre makes a change to their accreditation. This will include, but is not limited to, change of location, change of name or where a primary centre with an existing associate centre applies to have a new associate centre accredited.

<sup>9</sup> The fee applies to the programme being added to an existing accreditation. The fee is payable on application and is non-refundable.

<sup>10</sup> Digital assessment pilots are essential for all primary and associate centres. This includes new, transitioning and change of locations.

<sup>11</sup> Customers renewing associate centres will be charged one associate centre renewal fee regardless of the number of associate centres that are renewed.

<sup>12</sup> The audit fee is payable for the initial accreditation audit, and for all surveillance audits. All primary and associate centres are subject to audit.

The audit fee is also payable when a centre requires a re-accreditation audit following suspension.

Where the accredited training centre requests a cancellation or change to the agreed audit date, the following will be charged:

- Cancellation/Rescheduling on the day of the agreed audit = 100% of IWCF's current audit fee
- Cancellation/Rescheduling within 10 days of the agreed audit date = 90% of IWCF's current audit fee
- Cancellation/Rescheduling over 10 days of the agreed audit date = any unrecoverable costs incurred or 50% of the audit fee whichever is greater.
